



GDPR Policy

1. Introduction

This GDPR (General Data Protection Regulation) policy outlines the measures taken by Irfana Saeed Qureshi Online Personal Math Tutor to ensure the protection of personal data collected and processed during the provision of tutoring services. As a private tutor, I am committed to complying with the principles of data protection outlined in the GDPR.

2. Data Controller

Irfana Saeed Qureshi Online Personal Math Tutor acts as the data controller and is responsible for collecting and processing personal data for tutoring purposes.

3. Types of Personal Data Collected

I may collect and process the following categories of personal data:

- Contact information: Name, address, email address, and phone number.
- Student information: Name, age, school or educational institution attended, subjects studied, and academic performance.
- Parent or guardian information: Name, contact details, and any specific instructions or requirements related to the tutoring.
- Assessment and progress records: Information about the student's performance, assessments, and progress made during the tutoring sessions.

4. Purposes of Processing Personal Data

The personal data collected will be used for the following purposes:

5. Legal Basis for Processing Personal Data

The processing of personal data is necessary for the performance of the tutoring services and is based on one or more of the following legal grounds:

- Consent: When explicit consent has been obtained from the parent, guardian, or student.
- Contractual necessity: When the processing is necessary for the performance of the tutoring contract.
- Legal obligation: When processing is required to comply with applicable laws or regulations.

6. Data Retention

Personal data will be retained for as long as necessary to fulfill the purposes outlined in this policy or as required by law. Upon the completion of tutoring services or termination of the contract, personal data will be securely deleted or anonymized, unless retention is necessary for legal or legitimate reasons.

7. Data Security

I will take appropriate technical and organizational measures to ensure the security of personal data. This includes, but is not limited to, the following:

- Regularly updating software and systems to maintain their security.
- Using strong passwords and access controls to protect data.
- Encrypting sensitive data and confidential information.
- Restricting access to personal data on a need-to-know basis.
- Regularly training staff on data protection and security practices.

8. Data Sharing and Third Parties

I do not sell, rent, or share personal data with third parties for marketing purposes. However, it may be necessary to share personal data with the following parties:

- Parent or guardian: Information about the student's progress, feedback, and any relevant details related to the tutoring.
- Educational institutions: With the consent of the parent or guardian, we may share information with the student's school or educational institution to coordinate the tutoring efforts and support the student's academic progress.

I will ensure that any third parties involved in the processing of personal data comply with the GDPR requirements and have adequate measures in place to protect personal data.
